Incomplete or late applications will not be entertained.
3. Eligibility of the candidates in terms of service/recruitment rules and the advertised conditions shall be determined after the conduct of screening/shortlisting. On detailed scrutiny of the applications if they are found ineligible, their candidatures will be cancelled irrespective of the fact whether they have appeared in the examination/test or even qualified therein. The candidates should therefore, make sure before applying that they are eligible in all respects for the post, they are applying for.
