  - Fellow Member of ACCA
  
- Elements of Membership Pathway Programme
  - Membership Pathway Exam
  - Legal Module (for practicing license)
  - Completion and verification of practical experience

- Structure of pathway exam

  - Bridging Exam: PKR59,000 (approx. 268 GBP)
  - Legal Module: PKR14,000 (approx. 64 GBP)
  - Membership Fee: As applicable at the time of membership application

# MEMBERSHIP PATHWAY PROGRAMME (BY ACCA FOR FCMAs)

- Eligibility criteria
  - Fellow Member of ICMA Pakistan
  
- Elements of Membership Pathway Programme
  - ICMA Pakistan Pathway Exam (IPE)
  - EPSM module and assessment
  - Adapted practical experience requirement

# MEMBERSHIP PATHWAY PROGRAMME (BY ACCA FOR FCMAs)

- Structure of ICMA Pakistan Bridging Exam
  - Case Study examination
  - Duration – 4 hours (reading, planning and reflection)
  - All compulsory questions
  - 70-80 technical marks
  - 20-30 professional skills marks
  - Pass mark is 50%

# MEMBERSHIP PATHWAY PROGRAMME (BY ACCA FOR FCMAs)

- Application Process
  - Will be available on website
- Fees
  - Bridging Exam: GBP285 (includes study material of GBP40)
  - EPSM: GBP65
  - Membership Admission: GBP129
  - Membership Subscription: GBP258

# Existing Students Under Exemption Route

- Previously registered students/Members of both bodies may apply for registration under the Membership Pathway Programme (MPP) (provided they are active Fellow Members)
- No option of credit transfer/reimbursement of fees paid previously will be available
