Under the Listed Companies (Code of Corporate Governance) Regulations, 2017, there is a mandatory requirement for all companies to ensure that by June 30, 2019, at least half (50%) of the directors on their boards have acquired the prescribed certification under any SECP-approved Directors' Training Program.

In a major break-through for gender diversity in corporate boards in Pakistan, the SECP has required listed companies that their boards shall have at least one female director when it is next reconstituted not later than expiry of its current term or within the next one years from the effective date of these Regulations, whichever is later.

ICMA Pakistan is organizing 16th Directors' Training Programme at Lahore. Details of the programme is as under:

As per CCG Regulations 2017 (Chapter VII):

It shall be mandatory for every company to arrange training for:

a) at least one female executive every year under the Directors' Training program from the year starting June 30, 2019

b) at least one head of department every year under the Directors' Training program from the year starting June 30, 2021.
