AWARENESS SEMINAR ON DRAFT COMPANIES ACT, 2015

The Companies Ordinance, 1984 was promulgated to "consolidate and amend the law relating to companies and certain other associations for the purpose of healthy growth of the corporate enterprises, protection of investors, creditors and promotion of investment in the country".

The Pakistani economy, particularly the corporate sector, has considerably evolved and expanded. In order to assess the relevance of its objectives in the current economic environment and the adequacy of its provisions, not only for the achievement of its objectives, but for the creation and maintenance of a liberal, deregulated and efficient corporate sector, the Securities and Exchange Commission of Pakistan (SECP) constituted a Corporate Law Review Commission (CLRC) in November, 2005, to examine, assess and ultimately suggest amendments in the Ordinance or to draft a new law for the regulation of the corporate sector. In December 2015, the new Draft Companies Act, 2015 was uploaded on the website of SECP for public comments

The purpose of this seminar is to give the participants an insight into the various aspects of Draft Companies Act, 2015 (the draft) with the practical and theoretical approach to the draft.
