SPECIAL NOTE:

The Examination Progression Scheme [under Study Scheme-2018] has been implemented on the Online Examination Application Forms from June 2021 Examinations. Therefore, all the students are informed that from now and onwards, only the ELIGIBLE MODULE(S) will be available for selecting as exam paper(s) during the Online Examination Application Forms submission through the Institute's website. However, in case of any query, students may contact their concerned ICMA Pakistan centres for guidance.

Applications received after due date shall not be accommodated.
- (ii) Students are advised to opt their desired subject(s) carefully as the request(s) for change of subject(s) will not be entertained.
