Moreover, there is no facility available for change of exam day/ shift.
- 4- In case of Remote Access Examinations, the Exam Reporting/ Zoom Meeting Joining Time will commence thirty (30) minutes before start of the exam of your respective course(s). All examinees are, therefore, advised to report to the Proctor accordingly.
- 5- Examinees are also advised to verify/ check the contents of Admit Cards well before the start of the exams in order to avoid any difficulties with respect to log-in/ papers issues.
