- All examinations will be conducted as per Pakistan Time [PKT] ONLY.
- Examinees are advised to appear in the examinations at designated ICMA Pakistan Centres [for examinees appearing from inside Pakistan] or through prescribed procedure of Remote Access [for examinees appearing from outside Pakistan] and according to allotted specific date and time/ schedule mentioned in their Admit Cards. No examinee shall be accommodated from any other ICMA Pakistan Centre. Moreover, there is no facility available for change of exam day/ shift.
- In case of Remote Access Examinations, the Exam Reporting/ Zoom Meeting Joining Time will commence thirty (30) minutes before start of the exam of your respective course(s). All examinees are, therefore, advised to report to the Proctor accordingly.
- Examinees are also advised to verify/ check the contents of Admit Cards well before the start of the exams in order to avoid any difficulties with respect to log-in/ papers issues.
