# Subject: Membership Pathway Exam (MPE) and Legal Module Exam (LME), March 2024 – Membership Pathway Program (MPP) [For Fellow Members of ACCA]

The intended candidates are advised to note the following instructions for forthcoming **Membership Pathway Exam (MPE)** and **Legal Module Exam (LME)**, **March 2024**, for their understanding and compliance:

#### 1- VENUE FOR FORTHCOMING EXAMINATIONS:

The Institute's forthcoming MPE and LME, March 2024, are scheduled to be held at Karachi, Lahore, Islamabad, Multan, Faisalabad, Hyderabad, Peshawar, Quetta, and Outside Pakistan. The examinations at Outside Pakistan shall be conducted through Remote Access. Necessary guidelines/ instructions for Remote Access Exams will be issued shortly.

The examination **Model Papers** are already available on Institute's website and may be followed by <a href="https://www.icmainternational.com/mpp\_acca.aspx">https://www.icmainternational.com/mpp\_acca.aspx</a> for MPE and LME, March 2024, ready reference.

#### 2- ELIGIBILITY:

Fellow Members of ACCA [FCCAs] are eligible to be enrolled in MPE for acquiring CMA Certification. While, FCCAs, who have acquired CMA Certification under Membership Pathway Program (MPP) are eligible to take LME, for applying for Practicing Certificate of the Institute.

#### 3- EXAMINATION FEE:

The examination fee of MPE, March 2024, is **PKR 58,000** [which is included **(for this attempt only)** in the applicable price] and for LME, March 2024, is **PKR 16,000** for appearing from any of the examination centres.

#### 4- DATES FOR SUBMISSION OF EXAMINATION APPLICATION FORMS:

Students are required to <u>send the Examination Application Form [duly signed]</u>, which is available at the appended pages, to <u>exam@icmap.com.pk</u> for appearing in forthcoming MPE and LME, March 2024. The dates for submitting/ forwarding of Examination Application Forms is from Thu, 15-Feb-2024 to Tue, 20-Feb-2024.

PASSPORT SIZE PHOTOGRAPH.

#### 5- ACCEPTANCE OF APPLICATION:

Students must ensure that they have fulfilled all the formalities i.e. submission/ forwarding of shared Examination Application Form <u>within</u> **prescribed dates** and payment of fee at designated bank branch.
