Subject: December 2023 Examinations – All Eighteen (18) Courses from Operational Level-1 (OL1) to Strategic Level-2 (SL2)

Students are advised to note the following instructions for forthcoming **December 2023 Examinations** for their understanding and compliance:

SPECIAL NOTE

- (1) The students may opt to pay through online banking channel [Debit/ Credit Card] or through Kuickpay Payment Facility.
- (2) All the students are informed that only the ELIGIBLE COURSE(S) will be available. However, in case of any query, students may contact their concerned ICMA Branch for guidance.

1- PLAN SCHEDULE AND VENUE FOR FORTHCOMING DECEMBER 2023 EXAMINATIONS:

The Institute's forthcoming December 2023 Examinations are expected to be held as per the below given tentative schedule:

NOTE: During the submission of examination application form, it is strictly advised to <u>UPLOAD THE RECENT</u> <u>STANDARD PASSPORT SIZE PHOTOGRAPH WITH BLUE OR WHITE BACKGROUND ONLY</u>. Whereas, in case of uploading/ placing the old/ irrelevant photograph, Examination Application Forms may be rejected.

4- A- STEPS TO SUBMIT ONLINE EXAMINATION APPLICATION FORM AND EXAMINATION FEE SUBMISSION PROCEDURE:

- (i) Signing-in through Institute's website [by entering eight digit registration number and password].
- (ii) Selection of exam centre and desired course(s) and uploading/ updating recent picture [Passport size] [if required] and entering/ editing contact details [residential address, mobile number and e-mail address] as mandatory requirement.

B- MODE OF PAYMENT:

(a) Online Payment [through Debit/ Credit Card]:

- (i) In case of online payment of exam fee(s), click 'Proceed to Pay' button under 'Payment through Debit/ Credit Card' option.
- (ii) For online payment, bank charges will be applied.
- (iii) After successful payment, it will be considered as final submission of online Examination Application Form.

(b) Kuickpay Payment:

- (i) For exam fee payment through Kuickpay, the students may use the Mobile Banking Application.
- (ii) After payment of exam fee, voucher uploading is NOT required.

NOTE: In case of any issue relating to the fees payment, please contact your respective ICMA Branch.

6- ELIGIBILITY:

7- TIMETABLE/ EXAMINATION SCHEDULE AND ADMIT CARDS:

The timetable/ examination schedule and admit cards for forthcoming December 2023 Examinations will be available on the Institute's website [Students' Portal] in due course of time.

8- NO FACILITY TO CHANGE AN EXAM DAY/ SHIFT/ CENTRE:

There is no facility to change an exam day/ shift/ centre.

9- PROVISIONALLY REGISTERED STUDENTS:

All provisionally registered students are advised to **regularize their registration number** and submit their online Examination Application Forms for appearing in forthcoming December 2023 Examinations.

10- NO PROVISION FOR EXAMINATION FEE TRANSFER:
