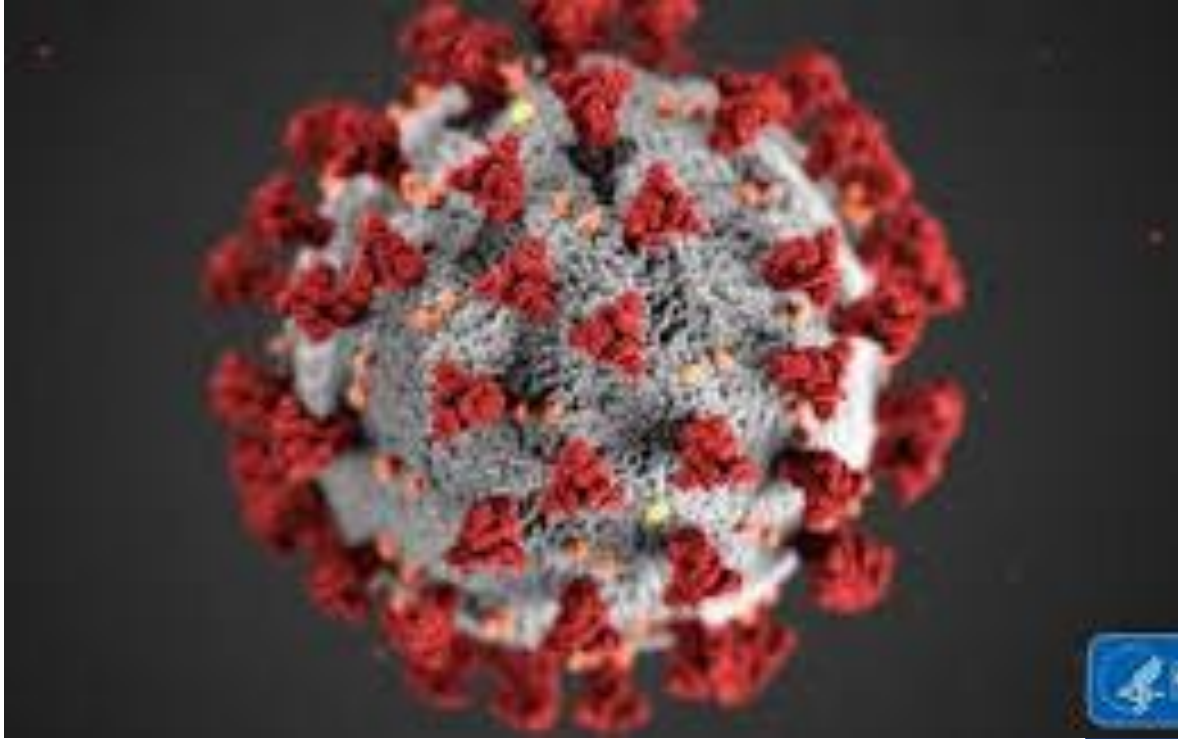

# How to Achieve social distancing during COVID- 19:



- One simple rule: workforce at workplace & families at home.

# Objectives:

- To keep economy & people least affected by COVID19
- to achieve maximum social distancing by:
  - Isolating workers at workplace &
  - Isolating Families at home
- To improve business environment with certain protocols.

# Pre-requisite:



**Creation of web portal “Social distancing” to control:**

Portal should be used:

- To Issue “permits” for business operations, stand alone factories,
- To register IDs on “Movement Control list” MCL.
- To register IDs on “Movement Authorization List” MAL.
- To register route permit for delivery VANS.(Deliver VANS)
- To register IT engineering firm or individual IT Engineer from renowned universities for developing APP for miscellaneous business. Rates should also be mentioned. (IT Industry).



**All people registered in MAL must wear protective dress.**



**All people having “Movement Authorization” should register their families on “MCL”.**



**Proper team should be assigned to entertain emergency cases for Hospitals only.**



**Strict implementation of rules & regulations OR implementation of rules & regulation with stick.**



**In peak hours 6 hours’ transmission at TV channels for public interest (religious, cultural, etc.) other than political debate.**

# Sector by Sector approach & solution

# Industrial Zones & Standalone factories.

All the entry gates of industrial zone or industrial estate/sites should be locked. Only 1 or 2 gates should be opened with tight security & scanning for entry of authorized vehicles.

Factories' owners should divide & declare their workforce into onsite & online workers.

Onsite workers should be sent to their respective factories for 3-6 Months with stay at factory premises. Accommodation & foods with necessities should be made available at factory premises.

Sanitized & cleaned buses should be contracted to bring workforce to factory premises.

Before entering to buses, onsite workers must go through preliminary medical checkup for fitness.

Online workers will be working from home & must not be allowed to move outside their home.

Factory owners should be given opportunity for certain employees to issue certificate "movement authorization", like supply chain management (SCM) or other administrative staff. This should be limited to a certain percentage of total staff like 5% of total factory strength.

Employees having "movement authorization" must register details of family members on the MCL.

Factory owners must also register details of family members on the MCL.

## Connected businesses:



- **Car Wash → Vehicle Sanitization Shop:**
- **General Stores, Medical stores, Retail shops, Taxis & Rickshaws, Restaurants, Dairy farmers & Farmers (allied industries):**
- **Shopping Malls & Markets**

# Car Wash → Vehicle Sanitization Shop:

- All car wash shops should be registered at portal & should be converted to vehicle sanitization shops.
- Sanitization shops should declare their per day sanitization capacity & then each vehicle sanitized should be registered on the portal.

## General Stores, Medical stores, Retail shops, Taxis & Rickshaws, Restaurants, Dairy farmers & Farmers:

All shops/farmers/owners must register on the portals with complete details.

All shops must register Taxi /Rickshaw as delivery man or riders.

Taxi driver must also register for a route permit of a designated area.

All shops /businesses must be stopped for direct customer dealing. Only through online or on phone deliveries.

# Banks, stockbrokers, real estate agent, Media Houses & other offices can't be operated online

- All such businesses should apply for “Movement authorization” for their branch or required staff.

# Construction industry

Big projects should arrange portable housing for labor. All steps mentioned for industrial zones should be applied.

Small projects should only use nearby labors. Where labor can stay at site or commute via personal means like bicycle or motorcycle etc.
